This PGY2 Pediatric Pharmacy Residency Program at Wellstar MCG Health is designed to provide the resident with a broad range of pediatric experiences in a progressive environment committed to pharmaceutical care and education. The program is customized to meet the individual needs and goals of the resident by providing numerous opportunities for patient care, research, teaching, and scholarship. Upon completion of this residency, the pharmacist will be a confident clinical pharmacy practitioner in pediatrics who engages in multidisciplinary collaboration, demonstrates advanced critical thinking skills, and is able to design and implement complex medication recommendations. The resident will grow into an autonomous and independent practitioner and have the ability to practice in a variety of different patient care settings.

Wellstar MCG is an academic medical center comprised of a 483-bed adult hospital and a 149-bed pediatric hospital located in downtown Augusta, Georgia.
